These General Terms & Conditions ("General Terms"), along with any applicable Additional Terms (defined below) (collectively, the "Terms") cover your use and access to the products, services, software, platform and websites (collectively, "Services") provided by Dr. Joe's Online Healthcare Clinic and any of our affiliates (collectively, "Dr. Joe's Online Healthcare Clinic "). By using our Services, you agree to be bound by these General Terms as well as our **Privacy Policy**.
